Event Details:

The First Annual McGreevy's Big-Mouth Beckett Burger Challenge Party will start at 4pm on Wednesday, August 25, 2010. The actual eating competition will begin at 6pm. Participants selected for the competition must check-in with Katie Emerson at the McGreevy's event check-in table by 5pm. Entrance to the party is a \$5.00 requested donation to the Beckett Foundation.

Competition Details:

McGreevy's will select 10-15 participants to compete in the First Annual McGreevy's Big-Mouth Beckett Burger Challenge. At the start of the competition, all participants will be asked to estimate their finish time. The participant who finishes the burger in its entirety in the shortest amount of time will be named the winner. The winner will receive a pair of Red Sox tickets in Josh Beckett's seats to an upcoming Fenway game. In the event of a tie, the winner will be determined by how close their actual finishing time is to their estimated time without going over their estimated time. To be eligible to enter the competition, each participant must raise \$125.00 towards the Josh Beckett Foundation. Each approved participant may bring 2 guests that will not have to pay the \$5 cover charge at the door. Guest names are to be submitted to Katie Emerson 24 hours prior to the start of the event.

All eligible participants who have been approved for the competition will be notified within 2-3 days of receiving this application form.

- Should a participant be observed hiding pieces of their Beckett Burger, dropping them under the table or placing them on another participant's plate he/she will be disqualified.
- Participants who suffer a reversal of fortune and/or urges contrary to swallowing will be disqualified.
- Participants must keep the Beckett Burger submerged for a period of two minutes after the competition.

McGreevy's Big-Mouth Beckett Burger Details:

Since May 2009, McGreevy's Big-Mouth Beckett Burger has raised over \$5,000 for the Josh Beckett Foundation. The burger comes dressed with lettuce, tomatoes, pickles & cheddar cheese and is approximately the size of home plate weighing in at 1 pound, 9 ounces in honor of Red Sox #19, Josh Beckett. The burger retails for \$30 with a portion of the proceeds going to the Josh Beckett Foundation. Every McGreevy's Big-Mouth Beckett Burger order includes a complimentary t-shirt; those who finish the burger receive a t-shirt; those who finish the burger receive a t-shirt announcing that they beat the burger; patrons who strike out and need a to-go container are given a t-shirt announcing that the burger beat them.
